BY-LAWS & RACE RULES**

**As of January 1, 2009 \*\*\*Note: rule change for a decrease in annual membership dues effective in Jan 09\*\*\***

**\*\*ARTICLE IX. DUES AND ASSESSMENTS**

Section 1. Family Members: Annual dues for family membership in the HCKC are \$250, January 1st to December 31st. (A new member will pay \$250 to join HCKC regardless of the date. His dues will be due the following January 1st and any excess he has paid will be credited to the second year's dues.) Pro-rating of dues exists for new members only - it is not applicable for a renewed membership if paid later in the calendar year. A member who resides more than 100 miles from the track will pay 2/3 of regular dues, rounded to the nearest \$5.

\*\*\*This membership has all the same rights, privileges and obligations as the Annual Membership as detailed in the HCKC Rulebook. The benefits of this membership include the following: Since membership is paid in full for 20 years they are not subject to the Annual Membership Fee increases. Also, all members of the immediate family are included. For example, if a family signs up and later a member of that family leaves and starts a new family unit, this new family unit also will have the same remaining rights as the initial family.
